# Zion Evangelical Lutheran Church Tamaqua, PA Congregational Meeting February 10, 2013

The 2013 Annual Congregational Meeting was called to order at 10:25 a.m. by president, George Taylor. We had a quorum with 37 recorded members.

John Haldeman offered an opening prayer.

**Report of the Secretary:** A motion to accept the minutes from the February 12, 2012 meeting was made by Paul Pecha with a second by Isabel Houser. All were in favor. A motion to adopt the minutes from the May 27, 2012 meeting was made by Darlene Fetterman with a second by Marlin Tirpak. All were in favor. A motion to accept the minutes from the October 21, 2012 meeting was made by Gerry Ziegler with a second by Ron Dietrich. All were in favor.

**Financial Reports:** Bob Jones reported that the audit team will be meeting shortly to review the books. Questions arose that needed to be answered by the Financial Secretary, therefore, Financial Reports were tabled until later in the meeting.

**Call Process Update:** Sandy Mehalko reported that the required 14 page report had been completed and sent to the synod. The team is working on 2 additional optional reports which will be submitted shortly.

George informed us that we were unable to make a satisfactory agreement with the candidate that the synod recommended as an "interim interim". Walter Weston informed us that Pastor Garbe told him that the synod has another candidate that will be reviewed. Until we secure someone, John Haldeman will fill in on Sundays, but a supply pastor will be used for Ash Wednesday and other Sundays when communion would be offered.

George requested all church members to read the article, "The Shrinking Church". He feels it is very pertinent to our current situation.

**Exterior Restoration:** Ells Davis gave an update on the status of the restoration. Phase 1 has been completed (the removal of the loose material). We are waiting to hear from CND from Bloomsburg who came on Wednesday to give estimates on patching or replacing the damaged areas of the church. We are also awaiting bids from other companies.

**Lawsuit :** George reported that the lawsuit is now in the hands of the lawyers as a settlement could not be agreed upon by both parties. It is currently in the pleading stage which could go on for 8 or 9 more months.

Pastoral Report: Our congregation was asked to call attention to Pastor Kistler's final report.

**Financial Reports, continued:** The Haldemans had asked a question about an amount of \$5 that was listed from the Rummage/Bake Sale Matching funds. Ann Marie Hadesty explained that the monies from the Rummage/Bake Sales go directly to Current (80%) and Outreach (20%). The \$5 shown was a missed amount so it was entered in that fashion and will be distributed appropriately.

Sandy Mehalko made a motion, with a second by Isabel Houser, to accept the Financial Reports. All were in favor.

**Stewardship Committee:** It was reported that 400 letters with pledge cards were sent to members, but only 50 responses were received. The purpose of the pledge cards is to help formulate a budget. We were reminded that stewardship is giving time, talent, and money to the service of the church.

**Mutual Ministry:** Judy Brennan gave an update. She reported that the terms of the current members are ending, and that new committee members will be appointed by a new pastor and the church council.

Laura Fulmer made a motion, with a second by Darlene Fetterman, to accept all reports. All were in favor.

Old and New Business: None reported.

Phil Gerace asked if the church council minutes would be available to members of the congregation. George said that they were posted on the bulletin board in the past, and would do so again, or they would be posted on the website after being approved and accepted at the meetings.

George reviewed the goals of the church for 2012 and shared the new goals for 2013.

He closed the meeting with a reading from Paul.

Judy Brennan made a motion, with a second by Marlin Tirpak, to adjourn the meeting. All were in favor.

### Zion Evangelical Lutheran Church Annual Budget Meeting Sunday, December 8, 2013

The meeting was called to order at 10:55 a.m. by president, George Taylor, who led us with an opening prayer.

There was a motion from the Congregational Council to adopt the 2014 Expense and Revenue Budgets as presented. Discussion and explanations of the budgets occurred. Ayes - 29 Nays - 0 Abstention- 2 Motion passed

There was a motion to table voting on the Constitutional amendment of the ELCA directive made by Mary Ruth Taylor, with a second by Paul Fegley. Ayes - 31 Nays - 0 Abstentions - 0 Motion passed

There was a motion from the Congregational Council to approve the updated Endowment Bylaws. Walter Weston was asked to explain the changes for the congregation. After a discussion period, a vote was taken. Ayes - 33 Nays - 0 Abstentions - 2 Motion passed.

It was announced that we have 2 members from council retiring: Walter Weston and Paul Pecha. Both men were thanked for their service by the congregations. The slate of potential candidates was presented: Mary Kay Davis, Paul Fegley, Phil Gerace, and Gerry Ziegler for first terms, and Rochelle Evanousky, Ron Dietrich, and Deb Davies for second terms. Ron Dietrich made a motion to close the nominations. This was seconded by Laura Fulmer. A paper ballot was taken with all candidates receiving more than the required number of votes needed to serve on council.

Sandy Mehalko updated us on the pastoral candidate and explained that the salary package was why he withdrew himself for consideration.

The idea of possibly using some of the Endowment Funds to supplement a pastor's salary was addressed. Various members of the Endowment Committee expressed their views as did several members of the congregation, both for an against its use. The paper ballot taken will only be used as a poll to see how the congregation feels about this. Before any money could be used, a specific package would have to be presented to the congregation for a vote. The result of the poll to use the Endowment Funds was as follows:

Yes - 16, No-18, Unsure - 1

If the Funds were to be used, what is the maximum amount that could be used each year? 10,000 - 3, 15,000 - 9, 20,000 - 3, 25,000 - 0, 30,000 - 1, Other - 0

Judy Brennan and Rochelle Evanousky reported on outside venues to possibly hold the annual meeting. The paper ballot showed 22 would like the meeting to remain at church, while only 8 would like to hold it at an outside venue; 3 abstained.

Jim Batman made a motion to adjourn, with a second by Laura Fulmer. Meeting adjourned.

#### **STEWARDSHIP 2013**

Giving of time, talents and treasures is an important part of all Christian faiths. Giving is not just a financial concern. Developing stewardship in a congregation takes more than a once-a-year-plea for treasures. It's really an education matter — a spiritual matter — that needs to be addressed year-round. A task force of members reviewed our current stewardship efforts in 2012 and developed a stewardship strategy which was adopted by Church Council.

At the urging of the Stewardship Committee, Church Council commissioned a group of members to explore offering an alternative to our tradition Sunday worship service. The new service started in July supplements our proud history of traditional worship. Its purpose is to serve those who cannot get to a tradition Sunday service or those who do not find the tradition service to be meaningful to them. In studying "resurrection congregations," we found that many churches once close to extinction began offering alternative worship styles as part of their "revitalization" plans.

#### **COUNCIL PRESIDENT'S MESSAGE - 2013**

"For I know the plans I have for you," declares the Lord, "plans to prosper you and not to harm you, plans to give you hope and a future. Jeremiah 29:11

"Everything will turn out all right in the end, and if it is not all right, then it is not yet the end." The Best Exotic Marigold Hotel

Not too long ago, I sent the above Bible verse to our oldest son, Brandon, who was in the midst of changing jobs. He was more than a little discouraged and changing jobs in China is not as easy as changing jobs at home. Within days, he had three job offers. Eventually, he took one of the offers and settled down in Hong Kong.

The quote from "The Best Exotic Marigold Hotel" may actually be from Beatle John Lennon, according to a Google search. Both Bible verse and quote apply to goals our congregation set in the last year.

The Call: Interim Pastor Rev. Jeffrey Kistler left us last January. After several months of waiting, the Synod sent us a candidate. The Call Committee met with the candidate and recommended the candidate to Council. Council met with the candidate and began salary negotiations. Unfortunately, no agreement could be reached regarding salary and the candidate chose to end the Call process.

What did we learn? Churches the size of Zion may no longer be able to afford a full-time pastor — at least a pastor with a great deal of experience. We also learned that graduates coming out of seminary training may not be able to afford coming to smaller congregations like Zion due to debt accumulated during their training. Sharing pastors may become a necessity.

We have discussed using money from the endowment fund. A poll taken at the December 2013 budget meeting (16 for and 18 against) showed that the congregation is somewhat evenly split on the use of endowment funds to help support a pastor's salary. Obviously, this discussion will continue when the Synod sends us another candidate.

We hear reports of people saying "I'm not coming back to church until we have a full-time Lutheran pastor" or "I'm not coming back until we have a male full-time Lutheran pastor." My personal view is that anyone who says such things does not have the best interests of the church in his/her heart.

We have done amazing things here at Zion in the last three years – two of them under the direction of Pastor Jeffrey Kistler and the last year pretty much on our own. I hope you took the chance to read the wonderful end-of-the-year letter sent out by the Finance Committee and Church Council. (A copy is included in this annual report.)

While this congregation has refused to go into hibernation without a pastor, we have no intention of "going it alone." We fully recognize the need for an ordained leader, so we jumped at the opportunity to work with Pastor Virginia Goodwin as interim pastor. Pastor Goodwin will be with us three Sundays in months with four Sundays and four Sundays in months with five Sundays. She will be in the office one day a week. Appointments can be made to meet with her. She will also be doing visitations. She has been asked to help us develop stewardship and Christian education initiatives.

Visioning and/Exterior Restoration: Members of the property committee and volunteers from the congregation have done a wonderful job in patching much of the lower level areas. Much work remains to be done. Estimates received ran about \$450,000 to patch (not repair) the exterior. A "visioning" group met in 2012 and decided it best to wait until a pastor is called to continue discussions about the exterior and future of the current church facility.

Stewardship: Though a stewardship program was developed and presented to Council for approval, it has not been implemented. One of the items we have asked Pastor Goodwin to help us with in the coming months is putting a stewardship initiative into action.

Policy manual: We continue to update and develop congregation policy and keep it all together in one manual.

Membership: Much work remains to be done. All of these areas remain goals for 2014.

Christian education: Spiritual growth does not end with Confirmation. Our second request of Pastor Goodwin is to help us to develop a Christian Education program that reaches all age levels. We grow as a congregation as we grow individually as Christians.

Alternative worship: We began a Saturday evening service in July and it continues under the leadership of a remarkable seminary student, Cindy White, with the goal of moving the service more and more towards a contemporary style. We plan to add a digital video projector to the Social Hall and update our current sound system. We need to understand and accept that the "one size fits all" way of thinking about worship limits our ability to reach out to our community.

Pastor Goodwin served three years in a church that eventually closed. How come? Despite Pastor Goodwin urging that congregation to "get out there" and see why some churches were attracting new members while there's was not, they chose not to. And so they closed their doors. I think we all understand that no more boats are coming from Europe full of Lutherans looking for a place to worship and call their church.

We have no intention of closing the doors here at Zion. While we have many issues to resolve, we also have many good people doing God's work both in the congregation and community. My wish is that everyone in our congregation could experience the warmth, fellowship and caring that comes from choosing to get involved in some aspect of our work here in Tamaqua.

Granted, not everything is all right – we have work to do. But God has a plan for us. He has led us to wonderful people like Pastor Virginia Goodwin and Cindy White. Indeed, God has a plan for Zion.

### **MEMBERSHIP-2013**

Like many mainstream American congregations, Zion is experiencing a shrinking congregation. Instead of accepting a membership decline as inevitable, a Membership Committee is reviewing trends in our congregation and looking for ways to reach out to inactive members, to engage new members and families of recently baptized children and to involve our younger members in the congregation and the community.

During 2013, the membership group contacted over 120 inactive members by letter. The letters provided information about the activities of the congregation and asked if there was anything the church could do for the individual or family. It was decided that individuals would not be removed from the membership roll but rather given an "inactive" status and moved to special section of Church Windows.

Membership also sent out 240 post cards to members not seen frequently on Sunday about the current call process and the start of the Saturday service.

Later in the year, an attempt was made to help the Parish Administrator update the congregational directory. It has been noted that quite a few phone numbers are no longer in service and we get quite a few returns after a mailing has been done. Church attendees were asked during Advent and on Christmas Eve to update their church information.

Without a full-time or interim pastor, new membership classes have been on hold.

#### **Call Committee Report**

After all the necessary paperwork was completed by the call committee, the Synod sent a candidate to Zion. The committee met with the candidate twice and came to a consensus that the candidate was found to be superbly qualified. The candidate was referred to church council to be interviewed. The church council met with the candidate and unfortunately we were not able to come to an agreement about salary. The candidate chose to discontinue the process.

The call committee believes the candidate should have not been referred to Zion since the salary requirements were exceedingly beyond what Zion could afford or was willing to pay. Based on information the committee received after the fact, the synod was completely aware of Zion's financial status before they referred the candidate to the call committee. Moreover, Zion provided the synod and candidate all requested financial information in the Ministry Site Profile as an early step in establishing the call process.

The committee believes the process is flawed. It is an inefficient process with too much opportunity for wasting the time of the candidate, the committee and church council. The process needs improvement. Either the synod must do a more thorough job in vetting a candidate's salary requirements before referring a pastoral candidate to a church for consideration, or Zion must establish and communicate a salary range (minimum/maximum limits) to the pastoral candidate before an initial interview is scheduled with the committee. There must be an 'up-front' understanding between church council and the pastoral candidate that a compensation package is negotiable and developed based on several factors but church council is not generally able to exceed the upper limit of the salary range associated with the job opening. Zion now has a financial package in place to begin discussions with future candidates.

We want to thank all the members of the committee for the time they have already given to the process. Marlin Tirpak and Art Connely have asked to step down from the committee and we are welcoming Paul Derr and Walter Weston to continue the work we do in looking for a shepherd for Zion.

# Property Report for 2013

#### INTERIOR

Family room: It is proposed that the Sunday school room adjacent to the Gathering Room be turned in to a Family Room with appropriate furniture and play equipment. The room would be used for parents who need a calming place. It would be equipped with a flat-screen video monitor so that the adults could follow the worship service.

Social Hall: Bids are being reviewed to install a digital projector and update the current sound system to accommodate the alternative worship service. The sound and video equipment will all be mounted in one centrally-located cabinet.

All emergency lighting fixtures have been tested, repaired and batteries replaced where necessary. Handicapped lifts were inspected and repaired.

An additional downspout was added to the back of the church to address a leak problem in that area. Shrubbery around church trimmed and dressed.

A changing table has been installed in the unisex bathroom.

The kitchen area passed inspection; a new fire extinguisher had to be installed.

Routine yearly maintenance to furnace and chimney has been completed.

Secured bids for oil delivery; awarded delivery to Rarick Oil.

#### EXTERIOR

We completed Phase 1 of the exterior restoration project in 2012 with the removal of all loose materials posing a safety threat to anyone walking by or parking near the church. Phase 2 involves getting estimates on the entire project and on specific areas of the building. We have an estimate of around \$450,000 to complete patching problem areas on the exterior. A Visioning Committee met in 2012 and suggested that the exterior work be put on hold until a permanent pastor is in place. Ron Dietrich proposed doing some lower-level patch work which was done in the summer and early fall.

#### CEMETERY

Council approved a request from Property to purchase a riding mower instead of hiring someone to mow the grass. The idea would be to recoup the cost of the mower in three years. Additional help is needed for cemetery maintenance. Rick Backman is serving as cemetery sextant. The burial policy was changed to include the cost of properly preparing and reseeding or resolding the grave.

#### THE PARSONAGE

The church has been approached to rent out the parsonage for June, July, August and September. Church Council is reviewing the request.

# ALTAR GUILD REPORT

During the past year, we had six members serve on Altar Guild. Thank you for your faithful service.

We serve the Lord by preparing the altar for worship with the communion Sacraments. We also take care of the paraments and fair linens.

Serving on the Altar Guild is a very special ministry and we wish to share this service with anyone willing to participate.

# Zion Finance Committee Report 2013

The Finance Committee at Zion Evangelical Lutheran Church is comprised of Robert Jones, Chairperson; Steven Ristila, Vice Chair and, recording secretary; George Taylor, Council President; Dave Gensure, Treasurer; Ann Marie Hadesty, Financial Secretary; Paul Pecha, Walter Weston and Council member Jim Batman. In February Mr. James McRoberts tendered his resignation from the Finance Committee and Jim Batman came on board to take his place.

We saw a need to update some policies and establish new ones in order to maintain fiscal responsibilities. In early 2013 an updated Money Counting Procedure was approved and not long after that a Fund Raising Policy was established. Later in the year it became apparent that with the investments of Endowment Fund being placed with Oppenhiemer the Endowment Committee should become a Sub-Committee of Finance. The Bylaws to reflect this were changed and approved by the Congregation at the December Finance meeting.

In March after discussion and serious comparison between three different providers a motion was made, seconded and approved to recommend Council contract with Verizon for the Church's Phone Plan.

A deal was reach with Goods N Stuff in May of 2011 to split profits 80/20 with 80% going to the Church and 20% for Outreach. As more emphasis has been placed on reaching out to the community there was consensus that the agreement had to be revisited. Therefore after discussion a motion was made and approved to make it a 50/50 split.

In May Finance Committee met with Property to discuss the purchase of the mower for the cemetery. Thru M & S Hardware the Church could buy the mower for 48 months interest free and also receive a 20% discount. Everyone seemed satisfied with this offer so Council approved the purchase.

As the Call Committee was meeting with a candidate these were some of the issues Finance was dealing with: What salary can the church afford ?

Will Endowment funds be needed? If so, how much?

If the new minister doesn't live in the parsonage, how much pastoral care will be available?

What to do with the parsonage?

At this time these issues are still being discussed as we await a candidate to answer the Call.

In October the Budget for 2014 was approved and sent to Council for their review and approval. The budget was approved by the Congregation at the December Finance meeting.

Stewardship in 2014 remains a hot topic. It is essential for Stewardship to work with Finance. This will be a goal for 2014.

From the above figures you will see that Budgeted Income Received did not meet what was needed to meet the budget thus resulting in a shortfall of \$33,492.91. On a positive note Budgeted Expenses fell below Budgeted Income by \$8,868.19.

While we ended the year with a surplus of over \$23,000, this is not as good as it first appears. The Budget included the pastor's salary. If we had been paying a pastor for the full year and there was no change in Income we would be facing a \$33,492 deficit.

In the end of the year appeal letter that went out the week of Christmas we shared with you the Good News of some of the things that have happened here this past year. I would like to show how much you and your Church have shared our financial resources with others who, without us to help, would have to look to someone else to fill the void.

Where do you fall on this chart of giving units in our congregation?

Granted, a "giving unit" varies from household to household. A husband and wife can be a giving unit. If only one is a member at Zion, he/she is a giving unity. Children with their own envelope numbers are giving units.

Let's not quibble about giving unit designation nor should we dwell on the bottom numbers. Let's look, instead, where we are as members of this congregation.

What would it take for each of us to move up one step this year? What would that mean to the congregation?

Not everyone comes to church every week. Some in fact only show up on Christmas and Easter and we're just glad they do feel a need to worship with us on those Holy Days.

While worship is an important part of one's spiritual life, we're not going to criticize people who don't worship regularly. Still, those who show up two times a year or once a month need to understand they have a financial responsibility to the congregation *every week* regardless of attendance. And unless they recognize and honor that financial responsibility, the church may not be here when they do choose to attend a service.

Stewardship is more than a financial matter - it's a spiritual matter. Each of us must consider what God is calling us to do in terms of how we use our given gifts. How can we better use those gifts to benefit others in 2014?

Stewardship and spiritual growth are tied together. And so an emphasis on Christian Education and spiritual growth is an important goal for this congregation this year. Our growth as disciples need not end with First Holy Communion and Confirmation.

Perhaps you will make it a personal goal this year to take advantage of spiritual growth opportunities offered by the Synod, Zion and other churches in the community.

Perhaps you will make it a personal goal this year to become a more active member of the congregation by becoming a Cleaning Angel, or a member of the Culinary Crew, or the Senior Choir, or the Rejoice and Sing chorus or the Property Committee. The list goes on and on. The rewards of involvement are many, but, unfortunately, pew potatoes never experience that joy, the fellowship or sense of belonging that involvement brings.

Our growth as a congregation largely depends on your growth as a disciple. Make 2014 a year of growth.

Everyone knows that interest and CD's has dropped below our inflation rate. Our goal is to give back 4 1/2 % of our average fund value every year. This year we decided to sell our two bond funds and then invest the proceeds in high dividend stock ETF's.

Also everyone knows that 2013 was the best stock market performance since 1997. We are happy to report that our returns for 2013 was a positive 19.88%

Our goals for 2014 should be: our continuing financial support for operations of our church and possibly help fund a new minister!

Whether working on the Putz, helping on the Culinary Crew to serve the 150 guests at the Advent breakfast, or decorating the Christmas trees in the Sanctuary and Gathering Room, we enjoy every moment because it creates special memories with friends and family here at Zion. Through all the excitement this season brings, we cherish the opportunities to worship our Lord and Savior.

Looking back over the past year we can be amazed at the way the Lord has used each of us in this congregation to serve Christ and help make a difference in our community. We do indeed have Good News to share for Tamaqua. We can be thankful to be a part of a church that faithfully supports its Mission Statement: Zion proclaims the Gospel of Jesus Christ through Word and Sacrament as Gospel messengers in the community. We seek to be instruments through which God transforms lives and strengthens relationships within families and within our community of believers.

What is the Good News to share? These are just some of the things that have happened here this past year.
