ANNUAL CONGREGATIONAL MEETING MINUTES SUNDAY, FEB. 9, 2020

Pastor Cindy White provided the opening Prayer.

President Frank Rudy called the meeting to order. A quorum was established with 39 members present.

Welcome and Introduction of Church Council and Staff: President -Frank Rudy, Vice-President – Chris Henritzy, Secretary-Darlene Fetterman, Sam Caley, Bonnie Painter, Tiffany Warden, Bob Maue, Nathan Gerace, Ernie Henritzy, Mary Ruth Taylor, Michael Haspe, and Glenn Fritzinger.

Staff: Melody Gensure - Parish Administrator Dave Gensure – Treasurer Ann Marie Hadesty – Financial Secretary Sandra Mehalko – Parish Musician Pastor- Cindy White

Secretary's Report: The minutes of February, March, and December 2019 Congregational meetings were approved on the motion of Tiffany Warden, seconded by Gerry Zeigler.

Reception of Financial Reports Treasurer - Dave Gensure Financial Secretary - Ann Marie Hadesty Audit – Steve Ristila All financial reports were reviewed and accepted on the motion of Mark Valentine, seconded by Sandy Mehalko.

Committee Reports:

Finance: Rochelle Evanousky reviewed the Financial Report and stated that Finance Chair, Bob Jones, does an excellent job of preparation. Members were encouraged to use Boyer's and Redner's tags and Amazon Smile, noting that every little bit helps. It was also noted that the gifts from Culinary and the use of Thrivent cards have been very helpful.

Endowment: Walter Weston stated reported that in 2019 we had a gain of \$58,792. Over the last 20 years, the Endowment Fund has provided \$354,438 dollars to the church, including the payment for the annual insurance.

Capital Campaign: Dave Fetterman reviewed the activities of 2019, including our work with the Consulting Firm Kirby Smith for the cost of \$10,000. With the help of our consultant, Jim Edwards, many activities were held, including Major Donor Gift Meetings, Leadership Gift Receptions, Vision Sunday, and Commitment Weekend. As a result of this work, an additional \$100,000 was received in gifts and pledges. A Pot Luck Dinner was held to celebrate the completion of this phase of the campaign. In 2020, we look to review pledges and giving to make sure we are on track as we pay off our Endowment Fund Loan for Phase 2 of the Exterior Restoration.

Property: Mark Valentine thanked the Cleaning Angels and the Repair Group for all of their time, which saves Zion a great deal of money. Both groups are always looking for volunteers. Work has been completed on Phase 2 of our Exterior Restoration. Projects for 2020 include replacing Sanctuary lights with LED lighting, exterior parsonage work, if possible, and replacing the chime tower roof.

Outreach: George Taylor highlighted many of the activities of 2019 that come under the Outreach umbrella, such as culinary events, Care Corps, food baskets, Goods' N Stuff, Diaper Depot and several others. Everyone is encouraged to help with, or

support all of our Outreach events, as they should be the focus of our mission. Ralph Derr announced that Culinary gave \$19.000 to Zion's Emergency Fund, along with a \$2000.00 donation to the South Ward Fire Company. Worship and Music: Sandy Mehalko thanked all of the people who help with our worship services. She is always looking for new volunteers.

Altar Guild: New members are always welcome.

Christian Education: Our new Christian Ed. Director, Michael Haspe has been very busy. He highlighted some of the things that are occurring. He stated that 15 children are enrolled in Sunday School, which is an increase from previous years. Confirmation students are becoming familiar with the Bible and studying Martin Luther and the Reformation. Deb Davies did a great job with VBS in 2019, with 75 students registered. Jim and Jan McRoberts will continue their Bible Study in the spring. The Loaves and Fishes Ministry should be ready to go for the fall of 2020. A monthly service at the Hometown Nursing and Rehabilitation Center has been very successful. The first year of our Remembrance Tree was successful and Nancy Thompson is looking forward to having more ornaments on the tree in 2020. We thank Advent Lutheran for their generous donation toward that project.

All committee reports were reviewed and accepted on the motion of Rochelle Evanousky, seconded by Sam Caley.

VII. State of the Congregation

The Attendance report and Giving Report were reviewed and discussed.

President's 2019 Summary: Frank Rudy noted several significant achievements, including the blessing of having a full-time pastor; the continued work of the Capital Campaign, allowing us to move forward with Phase 2 of our exterior restoration project; and the opportunities being provided by our Christian Ed. Committee, under the new director, Michael Haspe. He also thanked everyone who participated in any of the work or activities during the past year.

President's 2020 Goals – We need to proceed with faith! The main focus going forward will be to continue to work to meet our budget challenges through our new Evangelism/Stewardship Committee and the involvement of more members with our programs.

VIII. Old Business: Volunteers for our Annual Picnic are needed.

IX. New Business

Pastor's Goals – Pastor Cindy White stated that she loves her congregation and all of the people at Zion. She is looking forward to working with the new Evangelism/Stewardship Committee, beginning with the Evangelism portion of the program. She is also very excited to begin our new Common Ground Recovery Service ministry. Rev. Deb Taylor will preside over that service, and will receive reimbursement for her mileage. The service will take place on Tuesday evening twice a month.

- Eight cubic yards of mulch was spread around the shrubbery. Skip Anderson has volunteered to keep an eye on the shrubbery area and clean it when necessary.
- One third of the Phase 2 restoration project has been repaid in 18 months; estimate it will take 3 years to pay off the remainder. Phase 3 could start then.

CHURCH INTERIOR

- The ground floor (green) bathroom wall was repairs, but water damage is still a problem.
- Book shelves were installed in the downstairs worship area to increase book storage for sales events.
- Shelving has been installed on the back of the stage to give more kitchen storage space.
- Plans began for the sanctuary lighting project, which will be completed in early 2021. A new panel, new dimmers and LED light bulbs will be installed making the lighting brighter.
- Third floor storage areas have been cleaned and reorganized. Michael Haspe secured from a closed mall 20 shelving units, which have been installed in third floor rooms to better utilize storage space.
- Mark Valentine and John Eckert replaced thermostats and worked on several control valves.
- A hand washing sink has been installed in the kitchen. A new stainless steel preparation table will be purchased when one is available.

OTHER

- Three new phones were installed to facilitate communications in the building.
- A new computer was installed in the parish office. Old office computer moved to the library for counting purposes.
- The Girl Scouts stopped meeting in the church in March. Before that, Mark Valentine suggested that scouts be given an area that does not change and that their area always be reset if it is used for a church activity.
- All inspections completed kitchen, lifts and boiler.

- A cable modem was installed to facilitate worship live-streaming. Data interruptions continued until a new line was run from the corner poll to the building and a defective modem replaced. We purchased ethernet cable to run from the modem to the streaming areas. A recent problem may have been caused by a church neighbor hacking into the Zion WiFi. That issue has been resolved.
- George Taylor contacted DeGurchy for permission to hire one of employees to help write a grant to Foundation for Sacred Places. The employee said it would be too costly. Suggestion: Hire Pastor White's friend to write the grant and use the DeGruchy employee as a resource. The grant would be due by the end of March 2021.
- Facility use clarification: All use of the building must be cleared through Melody Gensure. Paperwork must be completed. Sexton contacted.
- The possible purchase of property on Mauch Chunk for a parking lot hit a dead end. The borough historical review committee said the church would have to provide proof that the building in question could not be restored at a reasonable cost. Council has decided to discontinue the discussion.
- Michael Haspe secured various clothing racks from a closed mall store used for the pop-up thrift store. We also got a jewelry case from that store. Jim McRoberts used his trailer to bring the case to Tamaqua. We have secured another jewelry case from the South Mall for use with future sales. Jim McRoberts has volunteered his car and trailer again for transport.

ENDOWMENT FUND 2020 REPORT

2020 was different with the COVID virus. The stock marked plunged fast in the March/April period. Fortunately, our investments recovered by years end to a gain of \$46,383 or 14.9%.



Also our parish gifts to the fund totaled \$87,464, which included a Bequest of \$84,835. \$372.085 was distributed to Zion in 2020.

Our annual return for this past year was 17,647The yearly give back to our church is calculated at $4 \frac{1}{2}$ % of previous past year's balance

I thank our parish for their support this past year. Also thanks to our committee member including Rochelle Evanousky, Robert Jones, Steve Ristila and Matt Warden.

As a closing thought, I want to note some similar finances with our church and my volunteering as one of the Directors of the Tamaqua Historical Society. Both have received major financial help with Bequests.

Zion Finance Committee Report 2020

Robert Jones, Chairperson; Steven Ristila, Vice-Chair; Dave Gensure, Treasurer; Ann Marie Hadesty, Financial Secretary; Pastor White; George Taylor; Walter Weston; Rochelle Evanousky; Matthew Warden and Council Member Sam Caley serve on Zion Evangelical Lutheran Church Finance Committee.

What a difference a year can make and to say 2020 was unusual is an understatement. We ended last year with a deficit but ended the pandemic year of 2020 with a surplus. We did not see that coming but it's true and we thank God for that.

We ended 2020 ahead of Budget by \$15,486.71.

Income 2020 \$282,179.43 Expenses 2020 \$274,993.76 Ahead \$7,185.67

Income 2020 with Campaign Removed \$227,128.19 Expenses 2020 with Capital Campaign Removed \$209,361.58 Ahead \$17,766.61

Other Income:

Charles Wagner Estate. Zion was bequeathed \$169,670.00 from this former member. Half or \$84,835 went into Endowment. The Church received \$55,257 for 2020 and will receive \$29,578.00 in 2021.

PPP Loan. Zion received \$15,400 from the Payroll Protection Program. This was created by the Small Business Association to help small businesses keep their workforce employed during the Covid 19 crisis. Small businesses and non-profits including churches were eligible to apply for these loans. The loans will be forgiven as long as the recipients use the money for payroll and related expenses.

Endowment Fund. Zion received \$17,647 to pay the annual insurance premium. Thanks to that committee for managing the Church's assets.

Culinary Crew. Many of their activities were cancelled because of the pandemic but they were still able to turn \$4,900 over to the Church. We thank the Culinary Crew for all their dedication and hard work.

Thrivent. Many of our members have savings invested with this organization. All qualified members are eligible to apply for 2 Thrivent Action Team Projects per year. Thrivent gives a \$250 "Community Impact Card" which is a VISA card which may be used as seed money to purchase supplies. Both Culinary and Property have in the past had Action Teams to work on various projects and socials. In addition Thrivent also has what is called "Choice Dollars". Eligible members can designate where Thrivent distributes a portion of its charitable money. The amount a person receives is based on their insurance premiums and contract values. As a result of this program Zion received \$1,534 last year. Also Diaper Depot received \$1,000 in Thrivent cards. We thank all of our Thrivent members for what they have done to help the Church throughout the past year.

Boyer's and Redner's cards. The Church received \$506.24 from Boyers, and \$111.17 from Redners. Please remember to use these cards when shopping.

Amazon Smiles. The Church received \$81.99 from this program.

Morgan Foundation. Diaper Depot received \$1,000 from this organization.

We the people of Zion are blessed to have received so much but keep in mind without the financial contributions from the PPP loan and the Wagner Estate we would not have been able to pay our bills. The weekly offerings and other income would not have been enough to cover our expenses.

We have a hard working, dedicated Finance Team and I thank everyone for all the effort they put into our work this past year. I especially want to thank Dave, Ann Marie and our Parish Administrator Melody for the exceptional work they do.

OUTREACH 2020

2020 ZION OUTREACH HIGHLIGHTS: 'BE' THE CHURCH

Zion supports many ministries that help Zion BE the church to its members, the community and beyond. As Christians, we are called to serve. Where would your talents have the most impact? What is God calling you to do?

Joyful Noise

January – \$123 to Save the Children February - \$100 to the Tamaqua Historical Society November - \$500 to Greater Philadelphia Diaper Bank (Zion's diaper provider)

Culinary

The pandemic has greatly limited Culinary activities in 2020, but the year started off well with the community sauerkraut event serving 160 dinners and collecting \$901 in donations. In February, we delivered 156 hoagies and 70 quarts of soup for a total of \$1,031. The pre-Lenten sauerkraut dinner made \$1,155 but a mid-March haddock dinner was the first of the pandemic cancellations that included the Easter candy and pie sale and the annual ice cream social which benefits a Tamaqua fire company. An October hoagie sale netted over \$1,000. An apple pie sale got over 115 orders. A November hoagie sale was cancelled. We would like to thank Zion members who contribute their Thrivent cards to Culinary projects.

Culinary paid for some updates to the kitchen including a hand washing sink and to-be-completed new cabinet doors and to-be-purchased new food preparation tables. Sonia Brode has donated a new industrial strength oven to replace the current double-decker unit.

We welcome increased support from our congregation at our socials and other events. In addition to attending Zion events or purchasing food items, members can help by distributing posters and sign-up sheets and collecting orders where they live or work. If you cannot attend a social, a contribution toward event expenses would be most helpful.

People's Pantry

Several members participated in the Reversed Advent Calendar project which provided additional food to stock the pantry. Food donations are appreciated year-round.

We have observed people outside the congregation putting food into the pantry.

Blanket ministry

In addition to their blanket making, Judy Brennan and Arlene Derr have been active making pandemic masks that have been sent as far away as the Carolinas.

Care Corps

This ministry maintains contact with Zion's homebound members. Thanksgiving meals were provided by Gail and Bob Jones. New Years Day sauerkraut dinners were prepared by Culinary and delivered by Gail and Bob Jones.

Hometown Nursing Center

Michael Haspe and Judy Brennan had been doing a Sunday service at the center once a month until the pandemic hit and visitors were not allowed. The ministry was well-received by the residents and was very meaningful for Judy and Michael.

Prayer Chain

Mary Ruth Taylor heads a group of around 17 people who handle prayer requests.

Prayer shawl ministry

Gwen Evans continues to make the shawls, which are blessed and given to those who would appreciate them.

World/community mission

We continue to support KIVA, a program that lends small amounts of money to individuals starting up small businesses. The money is repaid and loaned out again.

Cradle roll

Michael Haspe will be reviewing this ministry, which has provided families of baptized children with helpful parenting and religious materials.

Social media – See attached report

In addition to the Zion website, Facebook page and live-streamed services and concerts, we have subscribed to PhoneLiveStreaming.com, a service which allows anyone to hear our worship services and other messages on their phones. The first three months are being sponsored by three families of Council members. Homebound members get a phone call when a service is about to start. They are asked to stay on the line if they wish to hear the service. Other members can call a local number (570-393-2180) hear the service.

Diaper Depot - See attached report

This ministry provides free diapers to anyone living in the Tamaqua Area School District. We are a "pantry" of the Greater Philadelphia Diaper Bank. Depot members handle requests, bundle diapers and distribute them to parents and grandparents the third Saturday of the month. Depot workers have also gone to Easton to help the Diaper Bank unload and load trucks. Diaper Depot received a \$1,000 grant from the Morgan Foundation and over \$1,000 in Thrivent Action Team funds.

Loaves & Fishes

We purchased a video license and hosted two Family Movie Nights before the pandemic shut down such activities. Free popcorn, drinks and snacks were provided to the movie goers. The response was good.

Common Ground

Pastor Cindy White and a pastor friend went to California earlier this year to learn about recovery ministry. Again, the pandemic put a hold on this project. We hope that some day soon, we will be able to host a recovery worship service as sort of a satellite site of the Common Ground Recovery Ministry in Wyomissing.

Harvest Home

Food and cash donations were used to stock the People's Pantry.

Congregational directory - Put on hold due to the pandemic.

Halloween

Zion's Trunk or Treat family event was cancelled but we donated 50 pumpkins and bags of candy to South Ward Fire Co. to distribute on Halloween night.

Help the Hungry

The Tamaqua Area Faith Fellowship's annual Hunger Campaign moved from May to October this year. Due to the pandemic, no Hunger Walk or Empty Bowl Dinner were held. Instead, a virtual Hunger Walk was initiated. Zion contributed \$976 to the walk. A community total of \$8,939.15 was shared with the three food banks in town.

Blessings Boutique (thrift store)

Our pop-up thrift store ran for 6 days in October and 4 more days in November and made a total of \$6,229.97. This included the sale of clothing, household items and food items. Sonia Brode ran the kitchen for the first 6 days with donations from The Summit, the senior living community where Sonia works. Half of the amount raised is given to the church's general fund and half supports Outreach ministries. Dates in December and January were cancelled when COVID cases increased. Judy Brennan has proposed that Blessings be open two or three days a month providing enough help is available. First the first time, Zion was able to accept credit cards for purchases through the use of Square.

Christmas

Tree of Remembrance - This was the second year for this activity and was somewhat limited because of the pandemic and church services being virtual. Congregation members are encouraged to provide photos, which are made into ornaments hung on a special tree in the Gathering Room. Nancy Thompson brought this wonderful ministry to Zion.

Christmas cards - We prepared and mailed 260 cards this year. The cards included the then-planned Christmas Eve service schedule and an end-of-the-year letter.

Family event was cancelled due to the pandemic.

2020 Capital Campaign Committee Annual Report

Zion's Capital Campaign (CC) Committee currently consists of eight members: Pastor Cindy, Sandy Mehalko, George Taylor, Bob and Gail Jones, Frank Rudy and Darlene and Dave Fetterman. The committee began its works in April 2017. Due to the Covid virus the committee did not meet in 2020. We remain interested in having new members. Anyone interested in serving on the committee is asked to contact Dave. Committee members may include individuals who are not members of Zion.

*In 2020, the Capital Campaign Committee is excited to report that it has received from Zion members and non-members \$65,458.00 in pledges and gifts. This amount includes 2% interest paid (\$2,658.64) on the loan from the Endowment Fund. The contributions were made towards expenses incurred for the completion of Phase II of Zion's exterior restoration, including deGruchy and Romano construction costs totaling \$226,184.45 (including exterior parsonage repairs) and the balance of Kirby-Smith consulting fees (\$7,495.00).

*We currently have an outstanding balance of \$102,200.00 on the loan from Endowment for Phase II of the project. The new monthly loan interest payment is \$170.34. The campaign committee's current fund balance \$1,106.78. Since April 2017, because of your exceptional generosity and contributions from others, Zion's Capital Campaign raised approximately \$277, 500.00 towards the restoration of the church's exterior.

I am pleased to have completed my first full year serving as the Christian Education Superintendent at Zion. This year has not been without challenges due to restrictions as a result of the pandemic. Through our faith in God, we will persevere in new and innovative ways to spread Christ's message. <u>Classrooms</u>: Since the pandemic began, I have been carefully planning for the time that we can safely resume in person Sunday School classes. I am currently seeking matching individual school desks for each classroom to replace the folding tables. My hope is to find some that can be donated, or cheaply purchased. With school desks we will have more flexibility and control over socially distancing the children by giving each child their "own space".

<u>Children's Fellowship Area</u>: This year I began the process of creating a "Kids Fellowship Space" in Classroom 200 outside the Gathering Room. This concept is in response to the concerns that were voiced at a council meeting in 2019 regarding children's activities after church, and Sunday School. The room will give the children a safe space for fellowship and play. The cost for materials to build toy shelving has been donated thanks to a generous donation by donation by Thrivent & Brenda Hill. Toys have also been donated by several members, and citizens in our community. The project is currently on hold until after the pandemic.

Sunday School: Total Enrollment: 22 Teachers: Michael Haspe, Mary Ruth Taylor, Tiffany Warden Time: Virtual Recording through most of 2020.

This year was a challenge teaching Sunday School. Most of the year was done using a recorded format thanks to the help of George Taylor. There has been a break with Sunday School since September 2020, and the teachers and I are currently working on a new Zoom format Sunday School. With this format the children will be able to see and interact with each other, and their teachers. (A much better format than the children watching a pre-recorded lesson) The revised format will be used in 2021 until we can safely resume in person Sunday School.

Confirmation:

Total Enrollment: 5 (4 students to be confirmed on Pentecost 2021)

Teachers: Pastor Cindy White, & Michael Haspe

4 Students were confirmed at the Pentecost 2020 service on May 31. This service was open for confirmands and their families only. Students wore masks and were socially distanced. As customary confirmation took a break for the summer months, and Class resumed in September. The class experienced many cancellations due to the pandemic, church being closed, and issues we were having with the platform we use to teach the class virtually. The virtual issues have been solved and we now have a paid platform with technical support to teach class. The students are currently in Year B and working on New Testament Bible Study. With time missed this year it is important to note that students being confirmed on Pentecost 2021 have received the core elements of the Lutheran Confirmation Process including the Small Catechism in their first year of study (2019).

<u>First Holy Communion</u>: There were 0 children registered for First Holy Communion classes in 2020. The class is led by Pastor Cindy White & Michael Haspe.

<u>Vacation Bible School</u>: VBS was presented virtually this year. 30 children registered and received craft kits. We followed Group Publishing's 2017 Camp Out Theme. Since pandemic restrictions kept us from having an indoor program, the hope when the theme was selected that we would be able to hold in person outdoor VBS. Unfortunately, due to the pandemic this was impossible. This is the first time Zion has done a 3-day theme, and it worked out well for a virtual format. The theme

followed "Sally Spruce" (our own Pastor Cindy), and VBS Host Michael Haspe on a journey through God's Word, discovering the "Jesus is the Light".

Loaves & Fishes Ministry: We were off to a great start at the beginning of the year. We hosted our first two "Family Film Nights" with great success. Family Film night was a FREE event for families to enjoy a theater like experience, with Free Popcorn, refreshments, and snacks. Attendance averaged 75 people per event. Toy Story 4, and Aladdin were shown.

<u>Pierogi Sale</u>: A successful Pierogi Sale was held in March before the pandemic shutdown to benefit the Loaves & Fishes Youth Ministry. The pierogi sale was a lot of fun, and good fellowship was had. It could not have been completed without the help of very dedicated volunteers. The hope is to make this an annual fundraiser for the youth when the pandemic is over.

<u>Cradle Roll:</u> The cradle roll files are being reviewed. I am currently seeking replacement material for dated items.

<u>Adult Education at Zion</u>: At the beginning of 2020 It was my sincerest hope to begin Adult Sunday School. This idea came about through the requests of many members looking to further their faith during the Sunday School Hour. Unfortunately, because of the pandemic it has not been possible. When we are able to resume in person education, the class will be led by Deb Davies following the Sunday Morning Service.

<u>Tree of Remembrance</u>: Due to the church being closed during much of the fall/Christmas season the Tree of Remembrance was put on hold this year. Nancy Thompson is still making ornaments and planning our next tree. Promotion of the tree, and signups for the free memorial ornaments will begin in August 2021 in hopes to continue to grow this project. The project is funded by a generous donation from the Former Advent Lutheran Church.

<u>Adult Education Outreach</u>: Services were held in January, and February 2020 at the Hometown Nursing & Rehabilitation Center. Due to the pandemic we had to put our services on hold until further notice. Average Attendance: 25 Residents The Hometown Ministry team is composed of Pastor White, Michael Haspe, Judy Brennan, & Beth Marcavage.
